Specifically, please describe your experiences with the program and why you would recommend it.

*The combination of lived experience with cognitive/psychological/emotional/physical disabilities and my exposure to Disability Studies concepts/paradigms catalyzed development of a disabled identity. The DST program at the University of Toledo under direction of Dr. James V. Ferris, PhD. provide opportunities for intellectual and academic development. The skills I have as an unaffiliated researcher specializing in autoethnography, support my production of scholarly articles and presentation from Hawai'i to Malta and points between.*

Do you believe it would be fine to disclose a history of lived experience/psychiatric disability when applying to the program? If relevant, please explain your answer.

*Absolutely! As at least two faculty members with the DST program have visible disabilities, they are very supportive and inclusive. I am currently in my 14 year of recovery. As my journey through the program began just years after I sustained a severe traumatic brain injury involving coma/amenia of more than 10 weeks, I found the best support from faculty and university accessibility offices.*

*I teach in the School of Social Work and am strongly committed to supporting and mentoring students with psychiatric/psychosocial disabilities, proactively addressing ableism in the academy. Faculty at Pitt are overwhelmingly supportive of lived experience integration and many identify as community-engaged or activist scholars in their respective areas including decarceration, racial justice, and criminal justice reform.*

*Yes; the School regularly admits graduate and doctoral students with an array of minoritized backgrounds and is explicitly supportive of under-represented students, faculty and staff.*

*Chyrell Bellamy is a lived experience identified academic. PRCH also has many other lived experience staff in both community engagement/program delivery roles and academic roles. PRCH as a whole is supportive and genuinely inclusive of people with a lived experience but Chyrell is particularly focused on this space and really understands the challenges.*

*I was there as a visiting scholar and will be staying on in an affiliate role. Chyrell was the first lived experience mentor I've had for a research project and she really knows her stuff. She is personally and deeply connected to the work, a great advocate and an insightful critical voice. As an LGBT woman of colour she also brings an understanding of additional 'diversity' issues that is rare.*

*Do you believe it would be fine to disclose a history of lived experience/psychiatric disability when applying to the program? If relevant, please explain your answer.*

*Yes I think it would be encouraged, people are very open about their roles/experiences. Around half the staff have lived experience.*

*Do you have any other information or advice?*

*This is a very active program running many community programs, for someone with a practical bent this could be provide a useful PhD focus.*

*I was admitted based on a letter in which I described my patient advocacy activities. The chairman at that time was William Eaton, who is part time now. I found a few mentors to be very supportive. There are also training grants that require participation by underserved populations. I was on many of these because I identified as a person with a disability.*

*The mentoring is enh, depending on the advisor you get. It provides a great but stringent/stressful education and is a very high-powered, high-expectation research environment. There is little to no teaching, which is nice. There was one student who did her thesis on peer support organizations, but other than that the only "peer" research they do (as far as I'm aware) is community health workers in developing countries. The emphasis is on epidemiology and biostatistics.*

Do you believe it would be fine to disclose a history of lived experience/psychiatric disability when applying to the program? If relevant, please explain your answer.

*Absolutely fine. As I said, you have the option of specifically being appealing as a student because you would be eligible to fit those quotas for underserved populations and possibly receive NIH funding because of it.*

Do you have any other information or advice?

*It's quite stressful. There are legal requirements for accommodations due to disability, however, the office that handled them when I was there was staffed with people who knew nothing. The mentoring has the possibility to be absolute crap, so you have to be a high-powered self-starter.*

It nonetheless remains a good choice, as long as potential students understand what spaces in the school are safe and where problems may need to be navigated.*

I'd say that the PhD program in particular would be a flexible environment to learn, and I am always looking for good PhD students to work with on research projects, and have them teach undergraduate Disability Studies courses.*

Very professional and understanding.*

*Without question. Excellent disability advisory service also.*

*It simply hasn't been an issue to experience severe mental health on this programme with any staff member. They have been understanding and caring and made me believe I can get through.*

*The MSc is very inclusive of people with both lived and learned experience, valuing all perspectives. All staff members welcome diverse opinions and recognise that we are all learning together. The content of the course reflects a range of views on recovery and social inclusion. The program offers online and part time learning which fits with other life commitments, and staff are supportive of the specific needs of people with ongoing experiences of distress. The students and graduates of the course have been the most amazing advocates for the course.*

*I've personally found the whole experience inspiring and through-provoking, and it has increased my confidence and abilities. I've encouraged other people to apply and they have had similar experiences. Where people have chosen to drop out of the course for personal reasons, this has been handled sensitively and positively with an aim to ensure that it does not feel like failure - sometimes it's just not the right time for us. Consequently I would encourage people to apply.*

Do you believe it would be fine to disclose a history of lived experience/psychiatric disability when applying to the program? If relevant, please explain your answer.

*Absolutely! People with lived experience are positively welcomed onto the course. Additional support can be provided as needed through disability assessments. There is a positive understanding of the varied*

*educational pathways that might have been impacted by experiences of mental health services, so that the application assessments are adjusted.*

*Do you have any other information or advice?*

*Additionally, the course welcomes people from a range of backgrounds - including people who have been involved in any way with a range of mental health services (professionally or personally, including as a family member), and also people who have other backgrounds and are interested in thinking more about mental health and how that might fit with their existing roles.*

*The course is online and welcomes international applications. Many students and some staff members are based outside of the UK.*

*Any considerations for students with a history of incarceration or arrest?*

*Applicants are not automatically excluded through screening processes. The course positively welcomes people with a range of experiences. Please apply and have a conversation with the Programme Lead.*
